Dear Randy:

As we discussed on the telephone, enclosed is a copy of the court of appeal's January 10, 1996 opinion in Waters vs. USAA. It appears that even though Judge and Mrs. Waters made good witnesses, the court ruled that "emotional distress damages are recoverable in first and third party bad faith cases only when the insureds have suffered a financial loss," and there was no evidence of any "financial loss" presented by the insureds. The opinion includes a broad and very interesting discussion of the availability of emotional distress damages against an insurance company. Although the outcome was not favorable to the insureds, I am sure you will want to read the opinion.


